BRITISH JUSTICE — IN THE HANDS OF DAVID OWEN AND ANDREW YOUNG!

David Owen's way of getting "free and fair" elections is to hand over control of Rhodesia to the "liberation armies" of the Patriotic Front!

Since the beginning of the present year, the Patriotic Front's "liberation armies" have murdered 3 875 black Rhodesian civilians and 207 white Rhodesian civilians. Countless others have been maimed or disfigured. To take a few recent examples:

1. "Liberation forces" belonging to Robert Mugabe's wing of the Patriotic Front raided Elim Mission on June 23, 1978. Nine British missionaries and four young children (including a three-week-old baby) were bayoneted to death. Most of the women were sexually assaulted and one was mutilated. The children were dragged from their beds, in their nightdresses. One child had her tiny thumbs clenched in her palms.

Workers killed

2. "Liberation forces" belonging to Mugabe's wing attacked the homes of African workers on a cattle ranch near Mayo on June 30, 1978. A woman and five of her six children were forced into a grass-roofed hut and burned to cinders. Eight workers were shot dead and one was bayoneted to death.

3. "Liberation forces" belonging to Joshua Nkomo's wing of the Patriotic Front attacked an African village in the Zwimba Tribal Trust Land on August 15, 1978. Nine villagers were burned to death in a grass hut which the raiders set on fire. Eight others were shot or bayoneted to death. The villagers' only crime was that they were known to be in favour of the Rhodesian internal settlement.

4. "Liberation Forces" belonging to Nkomo's wing of the Patriotic Front have proudly admitted that they shot down an Air Rhodesia Viscount on a scheduled civilian flight from Kariba on September 3, 1978. Of the 56 passengers and crew, 18 survived

the crash of whom 10 (including seven women and two children) were mown down by gunfire and the bodies subsequently bayoneted. Nkomo's New York representative accepted responsibility for the killings, saying they had been done to prove the existence of "war zones" in Rhodesia! Nkomo himself (in a B.B.C. broadcast) claimed that his "forces" did not attack civilian targets but added that, had they done so, "there would have been no survivors"!

David Owen had described Nkomo as "the father of his people"! He hails him as one with "the vision necessary to have a non-racial Zimbabwe"!

Young's comments

Andrew Young has commented: "I can't imagine Joshua Nkomo or Robert Mugabe ever pulling the trigger on a gun to kill anyone . . . The violent people are Smith's people and hopefully they won't be around for the new Zimbabwe!"

Is this British justice? Surely the lives of black and white Rhodesians are more important than Nigerian oil, or President Carter's re-election, or the international socialist revolution?

Surely the Americans have no right to require a British Government to connive at the execution of British people?

Rhodesians — black and white — through their guts and determination have earned the right to fair play! It is NOT fair play to force them to bear the burden of sanctions while they fight a deadly war against the forces of international terrorism.
