### PROCLAMATION -

by

THE HONOURABLE CLIFFORD W. DUPONT, I.D., President in and over Rhodesia, Commander-in-Chief of the Armed Forces of Rhodesia and Grand Master of the Legion of Merit.

WHEREAS it is provided by section 52 of the Constitution of Rhodesia, 1969, that the President shall, when so advised by the Prime Minister, by proclamation published in the *Gazette*, prorogue or dissolve Parliament;

AND WHEREAS it is provided by section 11 of the Electoral Act, 1969, that in a proclamation dissolving Parliament in terms of section 52 of the Constitution and fixing a day or days for a general election referred to in section 29 of the Constitution, the President shall provide for the matters required by the said section 11:

AND WHEREAS the Prime Minister has advised me to prorogue and dissolve Parliament;

NOW, THEREFORE, under and by virtue of the powers and authorities vested in me as aforesaid, I do by this my Proclamation—

- (a) prorogue Parliament; and
- (b) dissolve Parliament with effect from the 29th July, 1974; and
- (c) fix four o'clock on the afternoon of Wednesday, the 7th August, 1974, as the hour and day at or before which the Registrar-General of Voters will receive nominations of candidates for election as a European Senator: and
- (d) fix three o'clock on the afternoon of Thursday, the 15th August, 1974, as the hour and the day at which, if a poll becomes necessary in terms of paragraph (b)

of subsection (7) of section 57 of the Electoral Act, 1969, the electoral college referred to in paragraph (a) of subsection (2) of section 13 of the Constitution of Rhodesia, 1969, shall meet at the House of Assembly for the purpose of electing the ten European Senators; and

- (e) fix the Chiefs' Hall, Seki, at nine o'clock on the morning of Tuesday, the 13th August, 1974, as the place, the hour and the day at which the electoral college referred to in paragraph (b) of subsection (2) of section 13 of the Constitution of Rhodesia, 1969, shall meet for the purpose of electing the ten African Senators; and
- (f) designate the Deputy Secretary (Development), Internal Affairs, as the official who shall preside over the meeting of the electoral college referred to in paragraph (e); and
- (g) fix midday on Saturday, the 6th July, 1974, as the hour and the day at or before which the Secretary for Internal Affairs will receive nominations of candidates for election as a tribally elected member of the House of Assembly; and
- (h) fix the following days, hours and places at which, if a poll becomes necessary in terms of paragraph (c) of subsection (6) of section 75 of the Electoral Act, 1969, the several tribal electoral colleges shall meet for the purpose of electing the tribally elected members of the House of Assembly—
  - (i) for the Zambezi Tribal Electoral College, Chiefs' Hall, Seki, at nine o'clock on the morning of Wednesday, the 31st July, 1974;
  - (ii) for the Highveld Tribal Electoral College, Chiefs' Hall, Seki, at nine o'clock on the morning of Friday, the 2nd August, 1974;
  - (iii) for the Manica Tribal Electoral College, Chiefs' Hall, Umtali, at nine o'clock on the morning of Wednesday, the 31st July, 1974;

- (iv) for the Lowveld Tribal Electoral College, Chiefs' Hall, Fort Victoria, at nine o'clock on the morning of Wednesday, the 31st July, 1974;
- (v) for the Kariba Tribal Electoral College, Chiefs' Hall, Ntabazinduna, at nine o'clock on the morning of Wednesday, the 31st July, 1974;
- (vi) for the Pagati Tribal Electoral College, Chiefs' Hall, Gwelo, at nine o'clock on the morning of Wednesday, the 31st July, 1974;
- (vii) for the Pioneer Tribal Electoral College, Chiefs' Hall, Gwelo, at nine o'clock on the morning of Friday, the 2nd August, 1974;
- (viii) for the Tuli Tribal Electoral College, Chiefs' Hall, Ntabazinduna, at nine o'clock on the morning of Friday, the 2nd August, 1974;

and

- i) designate each official mentioned in the second column of the First Schedule hereto as being the official who shall preside over the meeting of the tribal electoral college specified opposite his name in the first column of that Schedule; and
- (j) fix midday on Saturday, the 6th July, 1974, as the hour and the day at or before which the Registrar-General of Voters will receive nominations of candidates for election as a constituency member of the House of Assembly; and
- (k) fix Tuesday, the 30th July, 1974, as the day upon which, if a poll becomes necessary in terms of paragraph (c) of subsection (6) of section 82 of the Electoral Act, 1969, the poll shall be taken, which poll will, in accordance with section 88 of the said Act, commence at half past seven o'clock in the morning and close at half past seven o'clock in the evening; and
- (l) appoint each official mentioned—
  - (i) in the second column of the Second Schedule hereto to be the returning officer at elections in the European Roll constituency the name of which is

specified in the first column of that Schedule opposite to the description of each such official;

(ii) in the second column of the Third Schedule hereto to be the returning officer at elections in the African Roll constituency the name of which is specified in the first column of that Schedule opposite to the description of each such official.

Given under my hand and the Public Seal of Rhodesia at Salisbury this twenty-first day of June, in the year of our Lord one thousand nine hundred and seventy-four.
